

Website Privacy Policy

Your privacy is important to us at Wildberry Personal Chef (DBA Real Food Littles). Please read this privacy notice carefully as it contains important information on who we are, how and why we collect, store, use, and share personal information, your rights in relation to your personal information and on how to contact us and supervisory authorities in the event you have a complaint.

1. Who We Are

2. Children's Online Privacy Protection Act

This website and any products and services offered herein are not intended for persons under the age of 13. Wildberry Personal Chef (DBA Real Food Littles) does not knowingly collect information from anyone under 13 years of age. Wildberry Personal Chef (DBA Real Food Littles) prohibits children under the age of 13 from using all interactive portions of this website, including leaving any comments, filling out forms, or otherwise submitting information. Wildberry Personal Chef (DBA Real Food Littles) will not knowingly collect personally identifiable information from children under 13. If Wildberry Personal Chef (DBA Real Food Littles) learns it has any information or content from anyone under the age of 13, it will delete that information.

3. The Personal Information We Collect and Use

a. *Information Collected by Us*

Wildberry Personal Chef (DBA Real Food Littles) may collect, use, and is responsible for certain personal information that you provide when you voluntarily sign up for e-mails or free gifts, register for a class or presentation, leave comments, order a service or product, fill out any type of form, access private membership pages, or otherwise contact Wildberry Personal Chef (DBA Real Food Littles) via an online form or e-mail. The information collected may include your name, e-mail, address, phone number, and/or billing information. You are not required to provide any personally identifiable information to merely access or visit this website.

Wildberry Personal Chef (DBA Real Food Littles) may collect domain information, your numerical IP address, the type of browser you use, which pages you view, and the files you request. We may also use "cookies" (small files saved on your hard drive by your web browser) to analyze website performance, track user patterns, save information from your previous visits and customize your experience. If your browser sends a "Do Not Track" signal, only a generic cookie will be placed on your device while the website is accessed.

We will ask for your consent to allow us to use cookies. Wildberry Personal Chef (DBA Real Food Littles) or its third-party vendors may collect nonpersonal information through the use of these technologies. Nonpersonal information might include the browser you use, the type of computer you use and technical information about your means of connection to this website such as the operating systems and the Internet service providers utilized and other similar information. Wildberry Personal Chef (DBA Real Food Littles)'s systems may also automatically gather information about the areas

you visit and search terms you use on this website and about the links you may select from within this website to other areas of the Internet.

If you are located in the European Economic Area (“EEA”), we are regulated under the General Data Protection Regulation which applies across the European Union and we are responsible as controller of that personal information for the purposes of those laws.

If you are located in the United Kingdom (“UK”), we are regulated under UK data regulations known as “UK GDPR.”

b. *Information Collected from Other Sources*

We also obtain personal information from other sources, such as online course hosting platforms and credit card processors for paid products. Wildberry Personal Chef (DBA Real Food Littles) collects such information in order to send e-mails, fulfill orders, deliver services and products, complete customer transactions, improve website performance and customer service.

c. *Who We Share Your Personal Information With*

Wildberry Personal Chef (DBA Real Food Littles) respects your privacy and will never sell, trade or transfer your personally identifiable information to third parties (beyond what is necessary for fulfilling a customer transaction or for the basic functionality of an online service) without your consent.

We do, however, share personal data provided for paid products (e.g. your name and delivery address details) with our third-party suppliers, online course hosting platforms and credit card processors.

This data sharing enables you to pay for and access paid products. Those third-party recipients are based outside the European Economic Area or the UK - for further information including on how we safeguard your personal data when this occurs, see Transfer of your information out of the EEA, UK below.

Wildberry Personal Chef (DBA Real Food Littles) may release personal information to enforce its Website Terms and Conditions of Use, other Terms and Conditions, manage its business, protect users or the general public, or to otherwise comply with legal obligations.

If you give Wildberry Personal Chef (DBA Real Food Littles) your permission, it may also use personal identification information for internal or external marketing and promotional purposes.

On occasion, Wildberry Personal Chef (DBA Real Food Littles) may collect personal identification information from you in connection with optional contests, special offers or promotions. Wildberry Personal Chef (DBA Real Food Littles) will share such information with necessary third parties for the purpose of carrying out the contest, special offer or promotion. We will ask for your consent to such disclosure and use of such information, prior to your participation in the contest, special offer or promotion.

We reserve the right to transfer personal information in the event that we merge with or are acquired by a third party. We also may disclose your personal information for any other purpose permitted by law or to which you consent.

We will not share your personal information with any other third party.

d. *Whether Information Has to Be Provided by You and Why*

The provision of collection of personal data (e.g., name, email address etc.) is required from you to enable us to send you email, free downloads or paid products. We do not require you to provide any personal data in order to access the public areas of our website. We will inform you when we collect it whether you are required to provide the information to us.

e. *How Long Your Personal Information Will Be Kept*

We will hold all non-client personal data until you let us know you would like for us to delete it or unsubscribe from our marketing contacts, which you are free to do at any time. We will hold all client and customer personal data in our files for six years.

f. ***Reasons We Can Collect and Use Your Personal Information***

Wildberry Personal Chef (DBA Real Food Littles) collects and uses your personal information to send e-mails, fulfill orders, deliver services and products, complete customer transactions, oversee contests and promotions and improve website performance and customer service.

4. Use and Transfer of Your Information Out of the EEA, UK

This website is operated in the United States and third parties with whom we might share your personal information as explained above are also located in the United States. If you are located in the EEA, the UK, or elsewhere outside of the United States, please be aware that **any information you provide will be transferred to the United States**. By using this website, participating in any of its services and/or providing your information, you consent to this transfer.

5. Your Rights
